LETTER FROM THE LEADERSHIP

Dear Supporters of the Virginia Foundation for Independent Colleges,

Since its founding in 1952, the VFIC has raised more than \$150 million from individuals, corporations and foundations to support independent colleges. Last year alone, your support made it possible for the VFIC to distribute \$2.3 million to our fifteen colleges serving more than 27,500 students.

It is a challenging time for higher education. VFIC has helped our colleges meet those challenges and build on a tradition of academic excellence.

We know, for example, that students learn best when they can blend their classroom education with internships, research, or study off-campus. It is especially important that students with financial need have such opportunities. Last year, we secured support for 51 fellowships through the Experiential Learning initiative.

We know, too, that access to higher education is an important priority for our colleges. With your support for various scholarship programs, the VFIC awarded over \$1.1 million to deserving students. Our colleges and universities assist students from many backgrounds. An inclusiveness program enabled the VFIC to reach more than 200 Hispanic students and college representatives. We hope to expand these and similar efforts, including scholarship support.

VFIC schools are using technology to collaborate through the Blending Our Future initiative. Students can now take courses in foreign languages not offered on their own campuses. Last year, 23 courses were offered through the program.

This has been a transformational year for the VFIC. We moved our offices to downtown Richmond and expanded our leadership team. Billy Greer, past president of Virginia Wesleyan, became our Southeastern Regional Director, paving the way for Nancy Gray, past president of Hollins, to join the VFIC later this year as the Western Regional Director. Mary-Beth Johnson, who has served the VFIC for many years, now has the title Chief Operating Officer. And Ken Ruscio, past president of Washington and Lee University, assumed the VFIC presidency on May 1. With our current staff and a dedicated Board, we are poised for a busy and ambitious year ahead.

None of this is possible without your support – your financial support, of course, but also your commitment to one of the strongest systems of independent higher education in the country. On behalf of our VFIC schools, their students and faculty, we express our deepest gratitude.

BRINGING THE WORLD CLOSER. For the third year, the Language Exchange allowed member schools to provide a more comprehensive curriculum. Willing instructors and ample technology that enable host classroom and remote classroom interaction permit students at VFIC schools to study languages not offered on their campuses. Mandarin, Russian, Arabic and German make for easier exchanges and stronger cultural understanding. Greek and Latin, the classics, explain Western civilization, English and grammar – integral elements, like all languages, of a liberal arts education.

EXPERIENTIAL LEARNING

A MORE LEVEL PLAYING FIELD. Low-income and minority students and the first in their family to attend college take part less frequently in study abroad and other high-impact experiences. For the second year, VFIC fellowships helped equalize that imbalance, enriching students and enhancing post-graduation opportunities. Students heightened their self-awareness through study, internships and service-learning experiences at home and abroad.

SUMMER UNDERGRADUATE RESEARCH

23 SCIENTIFIC EXPLORATIONS IN-DEPTH STUDENT STUDY. Highly immersive, hands-on learning experiences "stick." Fellowships enabled students captivated by the sciences to develop and implement research methods through supervised summer projects on their campuses. Last year's fellows may unlock secrets behind optic nerve regeneration, or contribute to treatment methods for pressure ulcers, or unearth ways to reduce destruction of urban forests by a species of insect. Along the way, fellows potentially co-author and present promising research with their mentors and advance their prospects for post-graduate studies and meaningful careers in the sciences.


Fellowship Program has supported research activities that enhance the learning of professors resulting



IN THE FISCAL YEAR that ended June 30, 2017, the VFIC generated income totaling \$3,125,986. The average distribution to member colleges was \$158,484, for a total distribution of \$2,377,263.

100 percent of the operating expenses were covered by the VFIC endowment. *Figures provided are unaudited*.
