



## **2021 Libby and Hiter Harris Excellence in Undergraduate Teaching Endowed Fund/Award**

### **CRITERIA**

#### **Libby and Hiter Harris Excellence in Undergraduate Teaching Endowed Fund/Award**

- Each VFIC member college is invited to nominate one outstanding faculty member for this award.
- The faculty nominee should possess seven or more years of teaching experience in higher education.
- The key criteria to be considered will be the nominee's professional history, reflecting a strong, clear, and abiding commitment to excellence in teaching undergraduates.
- The award will provide funding to support the recipients' research and professional development.
- Nominations are due by **May 31, 2021**.
- The award will be presented at a luncheon recognition ceremony in Richmond on November 4, 2021.
- We ask the nominee to set aside this day in order to attend the luncheon, if they are chosen for the award.

### **NOMINATION PROCESS**

The nomination packet will consist of four parts and the application package should be submitted in the following order:

1. A one-page letter of nomination from the Chief Academic Officer of the VFIC member college, making the case for the candidate as a truly outstanding and highly respected professional with a deep and abiding commitment to the teaching / learning process.
2. Two letters supporting the nomination. One letter should be from a third party - e.g., department head, faculty colleague, and one letter from a current or former undergraduate student – giving additional perspective on the nominee's work and impact as a teacher. Letters should be no more than two pages in length.
3. A personal statement by the nominee, outlining his or her teaching philosophy. Statement should be no more than two pages in length using a 12pt font size with one inch margins.
4. The nominee's abbreviated curriculum vitae. CV should be no more than three pages in length.

### **CRITERIA**

#### **H. Hiter Harris III Rising Star Award**

- Each VFIC member college is invited to nominate one outstanding faculty member for this award.
- The faculty nominee should be untenured and possess no more than six full-time years of teaching in higher education.
- The nominee should be one who has demonstrated great promise early in his/her career.
- The award will provide funding to support the recipients' research and professional development.
- Nominations are due by **May 31, 2021**.
- The award will be presented at a luncheon recognition ceremony in Richmond on November 4, 2021.
- We ask the nominee to set aside this day in order to attend the luncheon, if they are chosen for the award.

### **NOMINATION PROCESS**

The nomination packet will consist of four parts and the application package should be submitted in the following order:

1. A one-page letter of nomination from the Chief Academic Officer of the VFIC member college, making the case for the candidate as a truly outstanding and highly respected professional with a deep and abiding commitment to the teaching / learning process.

### **CRITERIA**

#### ***H. Hiter Harris III Excellence in Instructional Technology Award***

- Each VFIC member college is invited to nominate one outstanding faculty **or staff member** (librarian, instructional technologist, etc.) for this award.
- There are no requirements for years of experience for this award.
- The nominee should be one who has helped to incorporate the use of technology in innovative ways in the undergraduate educational experience on their respective campus.
- The award will provide funding to support the recipients' research and professional development in the area of incorporating technology in the undergraduate educational experience.
- Nominations are due by **May 31, 2021**.
- The award will be presented at a luncheon recognition ceremony in Richmond on November 4, 2021.
- We ask the nominee to set aside this day in order to attend the luncheon, if they are chosen for the award.

### **NOMINATION PROCESS**

The nomination packet will consist of four parts and the application package should be submitted in the following order:

1. A one-page letter of nomination from the Chief Academic Officer of the VFIC member college, making the case for the candidate as a truly outstanding and highly respected professional with a deep and abiding commitment to incorporating technology into the undergraduate teaching / learning process.
2. One letter from a third party supporting the nomination. e.g., department head, colleague, or student – giving additional perspective on the nominee's work and impact on the undergraduate educational experience. Letter should be no more than two pages in length.
3. A personal statement by the nominee, outlining his or her philosophy as it relates to the incorporation of technology in the undergraduate educational experience. Statement should be no more than two pages in length using a 12pt font size with one inch margins.
4. The nominee's abbreviated curriculum vitae or resume. CV should be no more than two pages in length.
